Administration Report

Superintendent Klein gave the Principal reports. Band and vocal concert will be held Dec. 8^{th} , girls basketball opened Dec. 9^{th} , boys basketball will open Dec. 15^{nd} with an away game, Dec. 19^{th} is end of semester, elementary will have a movie on Dec. 18^{th} , elementary will host an open house on the 19^{th} from 12:00 noon to 1:30am. Christmas break will end on the 5^{th} of January 2015 and classes will resume.

Superintendent Klein reported on the bus repairs and suggested pre maintenance on two other busses. Two new scoreboards and shoot clock were donated by BankWest, and the stat board was donated by First Fidelity, Avera Gregory Hospital and Core Orthopedics. The school district will pay for installation. Klein discussed a new math curriculum and estimated cost will be about \$50,000.00. A committee will be formed in the spring to plan this new curriculum. Mrs. Klein attended a SASD meeting in which teacher pay was discussed. SD decreased 6% since 2000 and our surrounding states have increased. Wyoming at 24%, North Dakota 15%, and Nebraska 7%. The amount of students graduating from SD school is around 726 and the number of optional teacher retirees in the State is 1,004.

Sharon Pedersen gave the Mid Central Coop Report.

Curt Sinclair reported on the ASBSD Delegate Assembly. Here they discussed a Capital Outlay freeze on the 2014 levies. ASBSD would support this if legislation would agree to certain provisions. This will all take place during the 2014 Legislation.

It was moved by Sinclair and seconded by Wik to approve Bank West as the designated depository between the bank and the Gregory School District 26-4 and the State of South Dakota, County of Hughes. Yes: All present. Motion carried.

It was moved by Timanus and seconded y Sinclair to approve the open enrollment applications for students #16-14, #17-14, #18-14 and #19-14 for the 2014-15 school year. Yes: All present. Motion carried.

It was moved by Shoemaker and seconded by Pedersen to approve the resignation of Mary Frank, Title I paraprofessional, on December 19^{th,} 2014. Yes: All present. Motion carried. The board thanked her for her 25 years of service. The plan is to fill the position.
