Superintendent Anderson stated a special board meeting was held on August 3, 2020 to approve the "Return to Learn" school plan. The plan and protocols are posted on the school website. There are nine students that have signed up for off campus learning. The busses have not been inspected yet, but Foreman Sales have been contacted and inspections will be done by the start of the school year. Anderson had a meeting with the bus drivers. Masks are recommended on the school busses. Families are asked to sit together on the busses. After each route, the busses will be disinfected. The staff recognition gathering will be August 15<sup>th</sup> at the golf course. The online joint convention can still be viewed by the board members. The hail storm caused damage to the school vehicles. The insurance agent has been contacted. The open house for the new school year will be held on August 17<sup>th</sup>. Times are scheduled for the elementary students to come based on their last name, while middle and high school students are scheduled to come by their grade level. There will be an orientation for 6<sup>th</sup> grade students at 7:00 pm on the day of the open house. Inservice day for the staff will also be on August 17<sup>th</sup>. Interviews for the elementary secretary position will be held on Tuesday and Wednesday.

Principal Determan said that he is working on the elementary schedule. Cheer and dance and football practice has started. Volleyball and cross country start practice on August 13<sup>th</sup>.

Karen Timanus reported on CORE that a new policy regarding the surplus of vehicles was passed. The budget for the 2020-21 year was passed.

Anderson reported on Mid Central Coop that the next meeting will be held on September 14, 2020.

Activities Director Kurt Stukel reported that SDHSAA has COVID guidelines that are activity specific posted on their website. On bus rides to events, it is recommended that the students wear masks. Social distancing is being practiced as much as possible. Each athlete will have their own personal water bottle. Eight to ten students are going to be allowed in the weight room to still practice social distancing. The before school screening will be used for activities. Starting out there will no restrictions on attendance at activities. Gregory Gorillas Live will still be used for events. The Gregory Volleyball Tournament was canceled. Instead of a tournament, a triangular with Colome and Jones County will be held. Middle school sports are going forward as scheduled.
