He will finish this school year out. Anderson said that he has done an amazing job with the live streaming and thanks both he and his wife for their time and dedication. Parent-teacher conferences will be on October 23rd. Students will be dismissed that day at 1:30 pm. Conferences will go from 3:30-8:30 pm. The school is still following guidelines from the department of health regarding COVID and quarantining. Anderson has been in contact with neighboring schools regarding their COVID procedures.

Principal Determan reported that middle school football is over and middle school volleyball will be done on October 20th. Region cross country is in Platte on October 14th, while the state cross country meet is in Rapid City on October 24th. Dig Pink volleyball game is in Burke on October 15th. The end of the first quarter is on October 16th. State cheer and dance is in Rapid City on October 23rd. Parent-teacher conferences will be virtual. Donkey basketball has been postponed to a later date. The local oral interp contest will be on October 27th. There will not be a formal Veteran's Day program, but a program will be put together that will be broadcasts throughout the classrooms. There is no school on November 11th for observance of Veteran's Day.

There was nothing to report on the Mid-Central Education Coop.

Karen Timanus reported on CORE that the cooperative is surplusing some vehicles.

Timanus read a note received from Kellie Stukel. This note was in regards to dealing with COVID in the school, and the school procedures and guidelines.
