Superintendent Anderson reported that there is no school on January 17th for Martin Luther King Jr. Day. Midterm for the 3rd quarter is on February 2nd. On that day, there will be a 1:30 pm dismissal. On February 2nd, small group vocal contest will be held in Kimball. Elementary festival honor choir is in Brookings on February 10th. Parent teacher conferences will be on February 10th from 3:00-8:30 pm. There will be no school on February 11th. The 6th grade band will go to Brookings to perform on February 12th. GenPro electricians started the LED lighting project on January 10th. The project is expected to last three weeks. The work will be completed between the hours of 3:30 pm to 7:30 am. The spare bus that was purchased was delivered. The contract with COOP Architectures was signed for the building projects. Decisions on the projects will still need to be made. Anderson has been in contact with Chad Van Laecken from C&E Constructions. VanLaecken said that a settlement with the insurance company is close and is looking to be around \$1.6 million. This is over double of what was initially adjusted by the insurance company. The mask and vaccine mandate for Headstart did not go into effect as over twenty states have filed a lawsuit in regards to the mandates.

Karen Timanus reported that CORE had a standard meeting.
