Principal Jeff Determan reported that graduation and all end of the year ceremonies went well. The state track meet was held in Sioux Falls with numerous athletes participating. The boys' placed 4th overall as a team. The state golf meet was held in Rapid City, and was shortened due to rain. The boys team had qualified for state. All four team members placed in the top 15, with Coy Determan being the individual co-champion. The boys' team also won the team title, being the first team from Gregory to win a golf championship. Student schedules are still being worked on. The high school portion of summer school was completed on June 13th, while the elementary portion of summer school will conclude on June 30th. No middle school students signed up for summer school.

Superintendent Anderson stated that the buses are getting ready for inspections. Materials for the insurance work have started to arrive, but the work on it has not started. The addition/remodel project started on May 31st. The company to install the video entry system is still waiting on parts, so the work on that project has not begun. The handbook for the upcoming school year will be worked on. The Beef to School program has one out of the three spots filled for the upcoming locker appointment. The food service program is looking for other donations to fill the two empty spots.

Anderson reported on CORE Educational Cooperative that it was a standard meeting. There was an insurance renewal and a behavioral analyst/program supervisor, transition program specialist, and professional development coordinator positions were filled.
