### GREGORY SCHOOL DISTRICT 26-4 SEPTEMBER 13, 2021 UNAPPROVED REGULAR MEETING MINUTES

The Gregory School District 26-4 Board of Education met September 13, 2021 at 5:30 pm in the high school conference room. The following board members were present: Karen Timanus, Todd Schweigert, Jason Frasch, and Katie Bolander. Absent: Cara Hull.

Other officers and persons present: Sara Anderson, Superintendent, Kevin Myrmoe, Business Manager, Patty Connealy, Gregory Times-Advocate, George Kenzy, Shelly Kenzy, Tammy Graesser, and Brett Kenzy.

The meeting was called to order by Karen Timanus and the pledge of allegiance was recited.

During the visitors to the board meeting, Mr. Jared Opp presented the Gorilla Good News. Mr. Opp sent in a recording of last year's 5<sup>th</sup> grade band to the South Dakota Bandmasters and they were selected to play at their convention February 12<sup>th</sup> in Brookings, SD. The students, this year's 6<sup>th</sup> graders, were commissioned to play a brand new piece that has never been played before. They will practice with students from Arlington and together at the convention will play this new piece along with five other pieces.

George and Brett Kenzy presented to the board the Beef to School program. The Beef to School program is where local beef is used in the school lunch program. Typically, local beef is donated to the school. If some people want to donate to the cause but do not have a beef to donate, some at other schools have donated money towards the processing fee or the purchase of a beef. Ken Charfauros from Wall Meats called in to talk about the program. He has twelve schools involved, including the Burke School District. The meat that is provided from the program is local beef that has no filler in it. With him, the first beef is free to process. Charfauros sends the meat to SDSU for testing to ensure the meat is safe for the school. Wall Meats is federally inspected, which is a requirement for this program. The Gregory School District has three openings with Wall Meats in November, where the beef will be taken along with three for the Burke School District. The meat will then be delivered to the school. Going forward, more beef will be looked to be donated to continue this program. It has been discussed as well that local beef can be bought directly through Wall Meats to be used in the school lunch program.

Superintendent Anderson reported that they hope to have an updated estimate of the hail damage to the buildings soon. C&E Construction will come out on Thursday to order the steel that is needed for the repairs at the football field and they hope to do those repairs this fall. Rosebud Electric was contacted about putting together numbers for new lights at the football field as the hail storm damaged those and they were not accounted for when the first inspection was taken. Information on potential building projects, in which funds from ESSER II and ESSER III could be used were received. Estimates for the elementary remodel is \$369,472, weight room and locker rooms at the school is \$1,083,895, and a bus barn is \$1,112,512. At the next board meeting, the board can decide on which projects want to be completed at this time. A large portion of some of these projects would be paid for from the ESSER II and ESSER III grants and anything that would not be covered by it could be paid for out of capital outlay. A new used bus was purchased and another one will be coming in November, as one of the busses in the fleet will be retired as more repairs would need to be made. When the state bids come out for vehicles, a call will be made to secure a new vehicle as the school was unable to get one last year to replace the two Chevy Impalas that were totaled from the hail storm. There have been some positive COVID cases in school, but the students that are currently quarantined are due to close contacts away from school. School pictures are September 14-16. The marching band will go to Platte on September 17<sup>th</sup>. Financial aid night for junior and senior parents will be at 6:00 pm on September 15<sup>th</sup>. Mid-term for the first quarter is on Wednesday September 22<sup>nd</sup>. The band will be marching in the D-Days Parade in Vermillion on October 2<sup>nd</sup>. Homecoming week starts on October 4<sup>th</sup>, with Coronation on that day at 7:30 pm. The homecoming parade will be at 1:00 pm on Friday, October 8<sup>th</sup>.

Karen Timanus reported on CORE that they had a standard meeting. There was an update to their video presentation, the budget was adopted, and a return to learn procedure was approved.
