Superintendent Anderson gave an update on the hail damage repairs and remodel and building project. Wade Pogany, the director of ASBSD is resigning. The local legislators have been contacted and will look to plan a meeting with them in January. The governor in her annual budget address proposed a 5% increase to state aid funding. Anderson stated to be looking for legislation regarding the voucher program for state aid.

Principal Determan reported Gregory held its middle school and high school wrestling invites. The oral interp team came home from state with three superiors. Eli Barreto received a superior in the humorous category, while Dani Timanus did so in poetry as well as the reader's theater team. The elementary holiday concert is December 19th at 7:00 pm. The last day of the semester is December 21st. The elementary will have a movie day at the theater on the last day. Semester tests are December 20th and 21st. No school on December 22nd, but the staff will have an inservice day. The boys' basketball team plays at the Corn Palace on December 28th. Wrestling is at McCook Central on December 31st. Classes resume for the second semester on January 3rd.

Katie Bolander reported on CORE that they had a regular meeting and gave a recap of the delegate assembly meeting.

Karen Timanus gave a review of a meeting that the Burke and Gregory administration had that she and a board member from Burke attended as well in regards to the CTE/Trailer program. Concerns were brought forth about the conditions of the trailers and being able to continue moving them between the two schools. Repairs to the trailers were talked about, but nothing has been looked into to know the cost of said repairs. Discussion was had on the potential of only moving the welding trailer and not the other trailers, for the supplies could be moved back in forth instead of the trailers. The cost of moving the trailers was also discussed. A vendor from the Castlewood area has come down and moved the trailers since the inception of the program. Discussion was had on the possibility of looking at a vendor to move the trailers that is closer to the area. The importance of the program to both schools was noted and no decisions were made in regards to the program. The teams will meet in January to further discuss the program.
